Side Managers Guide to Conditions Of Play

THE DISTRICT HAS DELEGATED THAT THE HOME CLUB WILL PROVIDE AN UMPIRE & A CONTROLLING BODY (THE CONTROLLING BODY MAY BE A PLAYER)[GENERAL COP 22]

STARTING TIMES: VARY WITH EACH CLUB (SEE YOUR DRAW)

FORFEITS: 30 MINUTES AFTER STARTING TIME

PLAYER ELIGIBILITY FOR POST SECTIONAL PLAY: WOMEN'S COP 11.5 (MUST PLAY 50%)

Duties of Side Managers

Before the game:

Side manager to arrive 30 minutes before the starting time

Side manager to bring 2 cards

Home side manager to provide *result sheet*

Cards – **each side is recorded first on their own card**

A blind draw for opposing teams

A blind draw for rinks

Toss for the choice of the mat (applies to both teams)

Result sheet - enter all players' full names & **NATIONAL ID** AND opposite them their opposing teams' full details

During the game:

Scorecards – **Each Side is recorded first on their own score cards**

Scorecards - to be kept by the **SECONDS** before signing check that the score and time are correct. The cards are to be checked by the side managers.

Scoreboards - home team always on the left

Disputes - handled by the side manager only (with the controlling body)

Appeals - handled by the side manager only, to the umpire or the controlling body

Appeals - decision applies to both teams, e.g. rain or hot weather

Player Movement restrictions – State Women's Pennant COP & General COP 33.

After the game:

Winners - the side with the greatest margin of shots

Scoring:

3 points to the winner

1½ points each for a draw

1 point for each rink win

Total points to equal 5 for the match

Cards:

- ◆ 2 cards from the winning side - to accompany the result form
- ◆ 2 cards from the losing side - to go with the manager of the winning side
- ◆ Winning side manager to give the (losing side) cards to her club
- ◆ In a drawn game - the home side keeps one set of cards
- ◆ Home manager to post the result sheet & winning cards to the District Manager
- ◆ Winning side manager to ring the results to the District Manager within 24 hours (if possible please ring the results through before you leave the club)

Result form - please note that incorrect forms once signed by both managers will not be changed.

Your District managers: Side managers may ring anytime if they have a problem or query. You may leave results on the answering machine.

The game

Laws of the game applies

Players may have a 2 end roll up prior to the start time

The match consists of 2 games of 21 ends (42 ends)

36 ends constitute a game

A side manager may concede the match (if the team cannot win):

1. The remaining shots will be added to the total
2. Umpires permission not required

Players

A player may only play once in any one round

Players position may change each match

Players may change teams each match

Player restriction during season – Women's Pennants COP 11.4

Sides

A club with 2 sides in the same grade - players may not change between side A & side B for the whole season

Substitutes/Replacement

Laws of the game applies

General COP 34.1 to 34.7

Forfeits

The winning side manager will send in her cards & result form with "Forfeit" written on the opponents side

The players' names on the cards & result form is considered a round played - those players may not play in another grade in that round

Weather (hot or wet):

Only the side manager to contact the club - not later than 1 hour before the starting time

Play must commence within 1½ hours of the starting time

Incomplete or abandoned matches - all 4 cards are to be kept by the home club - duplicates of the 4 cards with the result form are to be sent to the District manager

36 ends constitute a game

Unfinished or unplayed games may be played at the end of the competition, if necessary.
